
DISMISSAL WITH PREJUDICE

Defendant Harbor Freight Tools USA, Inc. having settled with the Class and the Court on November 3, 2017 having granted final approval to the class settlement in this matter and entered its Settlement Order and Final Judgment,

IT IS HEREBY ORDERED, ADJUDICATED, AND DECREED that:

1. All claims of Plaintiff and all Class Members against Defendant are dismissed with prejudice.
2. Notwithstanding the dismissal of claims in the preceding paragraph, the Court shall retain jurisdiction over the construction, interpretation, implementation, and enforcement of the Agreement and supervise and adjudicate any disputes arising from or in connection with distribution of the settlement payments.
3. Any amounts remaining from undeliverable or uncashed checks shall be applied to Settlement Administration expenses.
4. Plaintiff and all Class Members are bound by the release of claims set forth in the Agreement and are hereby permanently enjoined and restrained from filing or prosecuting any Released Claims against Defendant.
